About 12,000 Member Dues Cards Delayed One Week Our vendor that prepares Moose Membership cards ran out of card stock during last Friday's card printing. This will result in about a one-week delay for 12,158 members whose cards could not be printed. These members' expiration dates are updated and correct in the MMMS/LCL.net system. Please work with them should they attempt to visit your facilities prior to their new card arriving. We regret any inconvenience this may cause.

Improved Tracking For Lodge, Chapter And Moose Legion Monthly Financial Transmission Implemented  
Moose International has upgraded its capability to track the reporting of required monthly financial transmissions from QuickBooks through LCL.net. All Lodges, Chapters and Moose Legions, except Moose Service Centers, are required to utilize QuickBooks to record their financial activity. Each month's activity must be transmitted to Moose International by the 10th day of the following month. Lodges, Chapters and Moose Legions failing to meet these requirements are in violation of our laws and subject to action against their officers, social quarters permit (lodges only) and/or charter.
