The "Moose Economic Stimulus Plan" Ends in Just 4 More Days

We are in the final 4 days of the "Moose Economic Stimulus Plan". The zero-dollar application fee program has already helped to generate nearly 59,000 applications since March 1, 2009. The program ends at 10pm Central Time on April 30, 2009. Any application transmitted to Moose International after this time, regardless of what date the application may have been received, will be billed to the Lodge, Chapter or Moose Legion at the standard application fee rate.

Any application reported under the "Moose Economic Stimulus Plan" where the applicant has NOT been reported as enrolled by May 31, 2009, will result in the reporting Lodge, Chapter or Moose Legion being billed for the application fee. All Lodges, Chapters and Moose Legions are encouraged to report all enrolled applicants by 10pm April 30, 2009.

Demand Prompts Chicago International Moose Convention Hotel Reservation Deadline To Be Extended AGAIN!

The response to last weeks announced extension of the hotel reservation deadline for the International Moose Convention in Chicago was sufficient for us to once again ask our three convention hotel partners (Hyatt, Sheraton, Fairmont), to keep our Official Housing open an additional week until 4:30 pm on Friday MAY 1, 2009. You and your members can still follow the instructions on the housing form which is on page 72 of the February/March issue of Moose magazine. Please ensure that your hotel reservations are completed this week.

PRE-Convention Registration Ends Tonight!

Pre-Convention Registration, at the \$50 registration rate, ends at midnight tonight, April 27, 2009. Onsite registration in Chicago will cost \$75. Only the hotel registration deadline has been extended to May 1st.

Monthly Financial Statement Reminder - "Moose Economic Stimulus Plan"

The April monthly Moose International financial statements will be mailed to Lodges, Chapters and Moose Legions in about a week. Even with the "Moose Economic Stimulus Plan" in place, it is possible to have application fees appear on these statements. Any application entered in LCL.Net with an application date prior to March 1, 2009, is billed the appropriate application fee regardless of the date the application is entered in LCL.Net and transmitted to Moose International.

Remember, any new or former member application entered under the "Moose Economic Stimulus Plan" AND NOT REPORTED AS ENROLLED by May 31, 2009, will result in the Lodge, Chapter or Moose Legion being billed for the appropriate Application Fee on their July Moose International financial statement. You are encouraged to immediately report as enrolled, any application that has been received with an application date after March 1, 2009, along with the first year's dues and which the membership has already voted favorably.

Important Year-End dates to remember Online renewal payments must be made no later than April 29th in order to be processed in time to be counted in this year. Similarly, payments mailed to the Moose International Dues Processing Center must arrive by the morning mail delivery on April 29th in order to count in this year's final totals.

Any completed applications received should be promptly entered in LCL.Net and transmitted to Moose International. In order to count in any recognition programs based upon applications reported, the application must be transmitted to Moose International prior to 10pm Central Time on April 30, 2009. If a Lodge, Chapter or Moose Legion also plans on reporting the applicant as enrolled in time to count in the 2008-2009 totals, the application must be transmitted to Moose International prior to 10pm Central Time on April 29, 2009.

Any application already transmitted to Moose International and "accepted", must be retransmitted with an enroll date, prior to 10pm Central Time on April 30, 2009 to be added as an active member prior to the April 30th year end closing.

2009-2010 Officers should not be entered until May 2, 2009! ONLY, current year officers who are no longer in office should be updated between now and April 30, 2009. Moose International will automatically enter an end date of 4/30/2009 for 2008-2009 officers.
